Part 1: Artist Agreement

Please review our terms and conditions. Check each item and sign at the base of the agreement.

The Museum of Craft and Design (hereafter called MCD) is responsible for the event STYLE '19 taking place December 7–8, 2019. The artist (hereafter called Vendor) whose work has been accepted agrees to complete this acceptance form and agreement no later than Tuesday, August 27, 2019. I understand and agree to the terms listed below:

PUBLICITY & MARKETING *

MCD reserves the right to use artist provided photographs or digital images of work for publicity. Artist publicity of the event is a requirement of participation. Vendors will be provided access to a downloadable media kit for use on their web, email, and various social platforms.

DELIVERY & INSTALLATION *

Vendor is responsible for all delivery, installation, and de-installation before and after the event. MCD cannot accept or store items at any time before, during, or after the event. Installation and setup will only be allowed on Friday, December 6 from 5 – 8 PM. If booths are not installed during this timeframe the Vendor will not be included in the event. The location of STYLE '19 will be within the exhibition space of the Museum of Craft and Design at 2569 Third Street, San Francisco, CA 94107.

EARLY REMOVAL *

□ No booths may be removed from the museum prior to the completion of STYLE '19. Breakdown and de-installation will immediately follow the close of the event on Sunday, December 8, from 5 – 8 PM.

FEES, SERVICES, AND MATERIALS *

- Vendors are required to pay a booth fee upon contracting. Apparel and Home artists will be assigned a Full Booth at 8' x 8' and includes up to two 6' x 2.5' tables and two chairs. The Full Booth fee is \$550.00. Jewelers and smaller item artists will be assigned a Half Booth with up to one 6' x 2.5' table and two chairs at \$350.00. The Style event coordinators will decide final booth assignments. Due to our intimate space, not all booth requests can be accommodated but will certainly be considered.
- Vendors are responsible for bringing their own mirrors, garment racks, tablecloths, wrapping supplies, boxes, bags, and decor. Electrical outlets are limited in the space, if you require an outlet please bring your own extension cord.

SALES & COMMISSION *

On all transactions, Vendors will receive 70% of net sales. MCD will be absorbing all credit card processing fees. Vendors will be paid approximately (3) three weeks after the close of the event and will receive a full accounting of their transactions. STYLE operates a centralized cash register and accepts cash and all major debit and credit cards.

INSURANCE & LIABILITY *

Vendor has, or will have at the time of STYLE '19, appropriate insurance to cover liability for all items. MCD will not be responsible for any loss or damage to Vendor's property or injury to Vendor (or its agents, employees, and/or personnel), or Vendor sales. Vendor assumes all risks of loss, damage, liability, injury, or destruction resulting from any cause whatsoever, including but not limited to acts or omissions by Vendor and hereby releases and waives any claims against MCD related to such loss, damage, liability, injury, and/or destruction.

CANCELLATION *

□ If a cancellation by MCD is necessary due to unforeseen circumstances, acts of a third party, or other circumstances which (in MCD's sole judgment) may compromise the event or the safety of event participants, then the event will be cancelled and no refunds issued to Vendor. If Vendor cancels its participation prior to the event, they forfeit their spot and are ineligible for entry in future STYLE events. Only accepted Vendors are able to sell or distribute their items and/or conduct activities at the event. The Vendor list and booth assignments are subject to change without notice. MCD does not guarantee any level of attendance at the event and there will be no refunds, under any circumstances, after the event is complete.

Signature and submission of this form shall imply an agreement on the part of the Vendor to the conditions set forth above. This form is a binding agreement between Vendor and MCD. If the Vendor does not adhere to the stipulations above they will be ineligible for entry in future STYLE events and may be withdrawn from the current event.
